Infrastructure anti-corruption strategies and good practices Training Session

The upcoming OECD training session offers a unique opportunity for infrastructure project owners and contracting authorities in Latin America to deepen the understanding of anti-corruption prevention and detection measures across the project life cycle. By engaging with global good practices and interactive learning experiences, participants will be equipped to proactively address corruption risks and enhance transparency in infrastructure projects. The training session will also be an opportunity to present new initiatives for quality infrastructure investments, such as the Blue Dot Network and how they can contribute to implement effective anti-corruption strategies, foster a culture of integrity and contribute to Latin America's sustainable and inclusive development objectives within the infrastructure sector.

Objectives

The upcoming one and a half day training session, organized by the OECD in partnership with the Colombian *Financiera de Desarrollo Nacional* (FDN), is dedicated to advancing anticorruption prevention and detection measures within the infrastructure sector. The primary goals of the training are to equip participants with an understanding of corruption risks inherent to infrastructure projects and to provide them with practical strategies and tools to effectively prevent and detect corrupt practices. The training will also be an opportunity to present ongoing work of the OECD Secretariat to support the implementation of international quality infrastructure standards. In particular, the first phase of the *Infrastructure Anti-Corruption Toolbox (I ACT)* will be presented and discussed with participants. I ACT aims to empower actors across the infrastructure value chain to implement good practice in the prevention, detection and sanctioning of corruption and to support a level playing field for business.

Target Audience

This training session is tailored for a diverse audience within Latin America's infrastructure landscape. The main audience are project owners and contracting authorities. However, given these measures apply to infrastructure projects across the entire lifecycle, the training also speaks to a broader set of stakeholders. Executives, senior management, legal experts, compliance officers, competition authorities, control and audit bodies as well as procurement specialists from both public and private entities are invited to participate. The training's content is designed to cater to individuals actively engaged in infrastructure across the entire project life-cycle. By bringing together professionals with varied roles and responsibilities, the training encourages cross-functional collaboration and knowledge exchange. Ultimately, the training aims to empower participants with the expertise needed to navigate the complexities of corruption within the infrastructure sector.

Project owners will be invited to present good practices with a particular emphasis on the requirements needed to ensure these strategies and policies go beyond compliance with minimum corporate standards (a "tick-the-box" exercise) and are effective in fostering a culture of integrity.

15:45 – 17:00	Session 4: Promoting healthy competition and alliance among construction stakeholders
	Infrastructure provides essential services to citizens, such as clean water, energy, and transport. Governments rely on competition to achieve lower prices, better quality and innovation. However, when competition is undermined, it raises prices and reduces the quality of the end product. This session will focus on prevention, detection and sanction of anticompetitive practices, including bid rigging and other practices to undermine competition through undue influence. Standards such as the OECD Guidelines for Fighting Bid Rigging in Public Procurement or the OECD Recommendation on transparency and integrity in lobbying will be presented.

DAY 2: PROMOTING INTEGRITY AND PREVENTING CORRUPTION ACROSS THE PROJECT LIFECYCLE

The second day of the training program will look at critical stages of the infrastructure lifecycle such as project appraisal and contract re-negotiations. Participants will also have the opportunity to engage in a dynamic discussion surrounding an upcoming guidebook developed by the OECD and provide insights from their experience and expertise, ensuring that the project aligns seamlessly with the specific needs and aspirations of the community it serves.

09:00 – 10:00	Session 5: Fostering integrity during project planning and appraisal
	The planning phase of an infrastructure project is key to ensure that only projects that maximize social, environmental and economic benefits are put forward. However, political influence or lobbying by can introduce biases favouring projects that suit political or private interests and do not have an adequate economic justification. Furthermore, initial mis-estimations of costs, delays and changes in the project design can be used to favour landowners and specific interest groups. This



session will discuss some of these issues and highlight different strategies that have been used to prevent private interests to influence project planning and appraisal.

Session 6: I ACT Guidebook – Insights from practitioners

A project-level vision is essential to embrace infrastructure's complexities and ensure the value of infrastructure development. It's on this principle that the Blue Dot Network aims to certify infrastructure projects based on 10 dimensions ranging from value for money, human rights but also anti-corruption and transparent procurement. The OECD will present an upcoming guidebook that will accompany projects seeking certification to achieve the requirements for the Blue Dot Network Element 7 on anti-corruption and transparent procurement. In this interactive session, participants will be invited to reflect on the guidance that would most be helpful both for project owners and contracting authorities.

Session 7: Contract management and re-negotiations

Corruption risks are present throughout the entire life cycle of an infrastructure project. While there are increased efforts to prevent corruption during the pretendering and procurement phases, risks are equally present during the construction, operation or maintenance phases. This session will look at contract management practices and renegotiation dynamics in Latin American to identify the main causes and potential risks for rent seeking and opportunistic firm behaviour.
