

Tax-to-GDP ratio

Tax-to-GDP ratio compared to other Asian and Pacific economies and regional averages, 2022


Georgia's tax-to-GDP ratio was 24.1% in 2022, above the Asia and Pacific (36) average of 19.3% by 4.8 percentage points. It was below the OECD average (34.0%) by 9.9 percentage points.

Tax-to-GDP ratio over time

The tax-to-GDP ratio in Georgia increased by 1.5 percentage points from 22.6% in 2021 to 24.1% in 2022. From 2007 to 2022, the tax-to-GDP ratio in Georgia decreased by 1.0 percentage point from 25.1% to 24.1%. The highest tax-to-GDP ratio in this period was 25.1% in 2007, and the lowest 22.3% in 2010 and 2020.



In the OECD classification the term "taxes" is confined to compulsory unrequited payments to general government. Taxes are unrequited in the sense that benefits provided by government to taxpayers are not normally in proportion to their payments. <u>http://www.oecd.org/tax/tax-policy/oecd-classification-taxes-interpretative-guide.pdf</u>

Tax structures

Tax structure compared to the regional averages

Tax structure refers to the share of each tax in total tax revenues. The highest share of tax revenues in Georgia in 2022 was derived from value added taxes / goods and services tax (43.0%). The second-highest share of tax revenues in 2022 was derived from personal income tax (29.1%).

It includes taxes on payroll and workforce, taxes on property and other taxes (as defined in the OECD Interpretative Guide).
