

Tax-to-GDP ratio

Tax-to-GDP ratio compared to other Asian and Pacific economies and regional averages, 2022


The Maldives' tax-to-GDP ratio was 20.4% in 2022, above the Asia and Pacific (36) average of 19.3% by 1.1 percentage points. It was below the OECD average (34.0%) by 13.6 percentage points.

Tax-to-GDP ratio over time

The tax-to-GDP ratio in the Maldives increased by 2.3 percentage points from 18.1% in 2021 to 20.4% in 2022. From 2007 to 2022, the tax-to-GDP ratio in the Maldives increased by 8.6 percentage points from 11.8% to 20.4%. The highest tax-to-GDP ratio in this period was 20.4% in 2022, and the lowest 8.8% in 2009 and 2010.



In the OECD classification the term "taxes" is confined to compulsory unrequited payments to general government. Taxes are unrequited in the sense that benefits provided by government to taxpayers are not normally in proportion to their payments. <u>http://www.oecd.org/tax/tax-policy/oecd-classification-taxes-interpretative-guide.pdf</u>




Tax structures

Tax structure compared to the regional averages

Tax structure refers to the share of each tax in total tax revenues. The highest share of tax revenues in the Maldives in 2022 was derived from value added taxes / goods and services tax (50.4%). The second-highest share of tax revenues in 2022 was derived from other taxes on goods and services (27.3%).

- Personal income tax
- Social security contributions
- Value added taxes / Goods and services tax
- Corporate income tax
- Other taxes on goods and services
- Other taxes



Other taxes may include income taxes unallocable to PIT or CIT.

In this country note, "other taxes" is calculated as total tax minus taxes on income, profits and capital gains, social security contributions and taxes on goods and services. It includes taxes on payroll and workforce, taxes on property and other taxes (as defined in the OECD Interpretative Guide).
